REDUCING STRESS ON CHILDREN DURING DIVORCE

Children Cope with Divorce is a one-time, four-hour educational program for parents experiencing divorce, separation or change of custody. Offered under the leadership of Franciscan VNS Home Care, it provides support and encouragement to parents, with an emphasis on the needs of involved children.

Topics covered include:

- How families experience divorce
- Typical reactions of children
- Developmental needs of children
- Pitfalls to avoid

Trained, professional co-facilitators lead each seminar.



NOTE: The seminar should be attended by parents only — no children, please.

Instructions for attending class:

Each parent should schedule his/her class within 30 days of filing for divorce. Attendance will be reported to the courts.

Before attending the seminar, we suggest that all parents go to the website, UpToParents.org, complete the “homework” and bring a copy to the seminar. The website offers parents the opportunity to focus on their child’s need for respect, predictability and ideally cooperation between parents.

We also suggest reviewing sharekids.com, for its scheduling and communication tools.

Fee: The fee for Children Cope with Divorce is \$70 per person payable by credit card or PayPal with online registration. If paying at the door, payment must be by cash or money order only.

In certain circumstances, fees may be reduced for qualifying persons. **Application for fee reduction must be completed and approved in advance. Call for more information.**

All sessions begin on time. Once the session has started, no one will be allowed to enter late. If you are unable to attend your scheduled session, you must call to reschedule or cancel at least 24 hours in advance or you will be charged a \$60 administrative fee.

- Cause number (This can be found on your petition for dissolution papers from the court or can be obtained from your attorney or by searching online at mycase.gov)
- Legal name
- Address
- Phone number and email address
- The other parent’s name
- Whether you would prefer NOT to attend the same seminar as the other parent. PLEASE NOTE: Spouses with current protective orders SHOULD UNDER NO CIRCUMSTANCES attend the same seminar.
